

DECISION

On the Change in Listing Registration

Pursuant to the Law on Securities dated November 26, 2019;

Pursuant to the Law amending and supplementing a number of articles of the Law on Securities, the Law on Accounting, the Law on Independent Audit, the Law on the State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, and the Law on Handling of Administrative Violations dated November 29, 2024;

Pursuant to Government Decree No. 155/2020/ND-CP dated December 31, 2020, detailing the implementation of a number of articles of the Law on Securities No. 54/2019/QH14 dated November 26, 2019, and Decree No. 245/2025/ND-CP dated September 11, 2025, amending and supplementing a number of articles of Decree No. 155/2020/ND-CP;

Pursuant to Decision No. 07/QD-HĐTV dated July 9, 2021 of the Chairman of the Members' Council of the Vietnam Stock Exchange promulgating the Charter on the organization and operation of the Ho Chi Minh City Stock Exchange;

Pursuant to Decision No. 22/QD-HĐTV dated March 16, 2026 of the Members' Council of the Vietnam Stock Exchange promulgating the Regulations on Listing and Trading of Listed Securities;

Pursuant to the application dossier for the change in listing registration submitted by Vietnam Construction and Import-Export Joint Stock Corporation;

At the proposal of the Director of the Listing Management Department,

HEREBY DECIDES:

Article 1. To approve the change in the listing registration of **Vietnam Construction and Import-Export Joint Stock Corporation**, with the following details:

- **Type of securities:** Ordinary shares
- **Securities code:** VCG
- **Par value:** VND 10,000 per share
- **Number of listed securities before the change:** 646,468,336 shares
(Six hundred forty-six million four hundred sixty-eight thousand three hundred thirty-six shares)
- **Number of securities subject to the listing change:** 51,707,909 shares
(Fifty-one million seven hundred seven thousand nine hundred nine shares)
- **Value of securities subject to the listing change (at par value):** VND 517,079,090,000
(Five hundred seventeen billion seventy-nine million ninety thousand Vietnamese dong)
- **Number of listed securities after the change:** 698,176,245 shares
(Six hundred ninety-eight million one hundred seventy-six thousand two hundred forty-five shares)
- **Value of listed securities after the change (at par value):** VND 6,981,762,450,000
(Six trillion nine hundred eighty-one billion seven hundred sixty-two million four hundred fifty thousand Vietnamese dong)
- **Effective date of the listing change:** August 26, 2026
- **Reason for the listing change:** Issuance of shares for dividend payment
